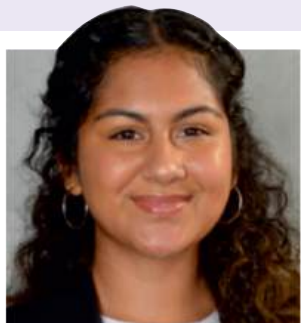

The changing global landscape has been significantly shaped by a series of intricate disruptions, ranging from economic uncertainties to environmental challenges and social upheavals. In response, governments, organizations, and leaders worldwide are actively seeking ways not only to safeguard our way of life but also to enhance our present and future prospects.

◆ September 2024 in the United Nations, the global leaders adopted the Pact to the future, which will give a boost to the Cooperative Economy G-Locally. The Panchasheel (Five Sutras) hinges around the solutions to 21st century problems is all about Cooperation and have laid out the basic framework for transformation to ESG from SDG.

◆ Turbocharge the Sustainable Development Goals (SDGs) and the Paris Agreement on climate change,

two landmark 2015 agreements that have seen halting progress and missed milestones.

◆ Listen to young people and include them in decision-making, at the national and global levels.

◆ Build stronger partnerships with civil society, the private sector, local and regional authorities and more.

◆ Redouble efforts to build and sustain peaceful, inclusive and just societies and address the root causes of conflicts.

◆ Protect all civilians in armed conflict.

◆ Accelerate the implementation of our commitments on women, peace and security.

◆ India's role in the achievement of the SDGs is crucial, given its vast population and diverse development challenges. Despite ongoing efforts, India has struggled to meet several SDG targets and is considered an outlier in terms of performance on these goals. However, recent initiatives and policy measures have shown promise, with NITI Aayog's latest SDG India Index indicating an improvement in the country's overall score across SDGs.

With India assuming the presidency of the G20 in December 2022, it is presented with a unique opportunity to accelerate its progress towards the SDGs. To effectively achieve these targets, it is imperative for India Inc. to align its business practices with broader societal and environmental goals. This includes integrating Environmental, Social, and Governance (ESG) considerations into their operations and decision-making processes. ESG refers to the three central factors in measuring the sustainability and ethical impact of an investment or business.

Environmental criteria assess how a company performs as a steward of nature, including its impact on climate change, resource use, and pollution. Social criteria examine how a company manages relationships with its employees, suppliers, customers, and the communities where it operates. Governance deals with a company's leadership, executive pay, audits, internal controls, and shareholder rights. In India, there has been a notable increase in awareness and adoption of ESG practices among companies. This is evident in the fivefold growth in internet searches for ESG criteria since 2019. Companies of all sizes and across industries are allocating more resources to improve their ESG performance.

Additionally, stakeholders and investors are increasingly scrutinizing companies' ESG practices, emphasizing the need for transparency and accountability. Sustainable Development Goal (SDG) 5 aims to achieve gender equality and empower women and girls by eliminating discrimination and violence against them, promoting equal access to education, healthcare, and resources, and encouraging women's participation in leadership and decision-making.

Key targets include ending child marriage, recognizing unpaid domestic work, ensuring reproductive health rights, and leveraging technology for women's empowerment.

The "Women and Men in India 2023" report emphasizes the crucial role of gender equality in achieving all UN SDGs. The report also outlines a Minimum Set of Gender Indicators, which includes 51 quantitative and 11 qualitative measures to track progress in economic empowerment, education, health, and public life. While the private sector has a significant role, there is an even greater need for governments worldwide to establish a supportive regulatory environment for advancing ESG goals. Sustainability and green development have become focal points, expected to drive increased green financing, despite challenges such as global uncertainty and capital outflows.

As a result, organizational strategies are increasingly aligned with priorities related to climate change, decarbonization, ethical supply chains, circular economy, diversity, equity, and inclusion (DEI). These strategies are built on a strong foundation of good governance and are supported by comprehensive ESG frameworks, measurement, reporting, and assurance mechanisms. Cooperatives, with their democratic governance structure and community-focused approach, play a critical role in advancing ESG goals. They inherently align with the principles of sustainability, equity, and social responsibility, making them key players in the push toward achieving the SDGs. Cooperatives can serve as catalysts for change, fostering collaboration and shared value creation among members and stakeholders.
